### **Billable Costs**

**Emory Tuition:** Since the students who are participating in the program will be fully enrolled at Emory and receive Emory credit, they will be charged regular Emory tuition for participation in the program. The tuition bill will come from Emory's Office of Student Financial Services during the normal billing cycle for the semester. The non-refundable \$300 application deposit will be applied towards program tuition. Existing federal and Emory-based financial aid will be applied towards the program costs. The "billable subtotal" above lists the charges that will appear on the Emory OPUS bill. The "non-billable subtotal" above lists the additional estimated expenses. All costs are subject to change.

### **Non-billable Costs: Additional Estimated Expenses**

The following items are only estimates of additional expenses to be paid directly by student including airfare, personal expenses, and additional meals. These additional expenses could vary greatly depending on the individual student's spending habits, restaurant choices, personal shopping and additional travel plans. Please refer to the glossary items in the program cost sheet.

Students with a high level of financial need may qualify for a waiver of the \$75 application fee and a deferment of the \$300 deposit; students should contact their Education Abroad advisor for details/eligibility. Students who receive the deposit deferment are held accountable to the same [refund policy](#) as those students who submit the deposit; you will be billed \$300 if you withdraw from the program, in addition to any applicable withdrawal fees.

***Please note:*** The cost of living abroad may be higher than the U.S. due to the [exchange rate](#) between the U.S. dollar and local currency.
